## Monthly MARTA on Breeze Card (Payroll Deduction or Cancel deduction):

To encourage the use of alternative transportation, the University subsidizes the MARTA University pass program for faculty and staff purchased through payroll deduction. The rate is subject to change based on MARTA pricing to the University. The additional subsidy is <u>only</u> available through payroll deduction.
Deduct the monthly amount for a MARTA Pass (Automatically adds the benefit to your Breeze card each month)
Cancel the monthly amount for a MARTA Pass (Stops deduction & loading of MARTA rides to Breeze)

This is a pre-pay program; deductions made in one month will pay for the following month's MARTA Breeze benefits. For example, January's deductions will pay for February. You must enroll or cancel by the 14th of the month in order for the MARTA pass to load or not load on your Breeze card for the following month. MARTA Breeze cards are prepaid and are not eligible for any refunds.

Employees, who miss the cut-off on the 14<sup>th</sup>, may purchase the MARTA Breeze card benefit at the discounted rate at a MARTA kiosk. (Note: University subsidy is <u>not</u> available at kiosk). In order to purchase the <u>next</u> month's MARTA pass, the purchase at the Kiosk must occur <u>on or after</u> the 23<sup>rd</sup> of the month. A purchase at the MARTA kiosk <u>before</u> the 23<sup>rd</sup> will result in the <u>current</u> month loading to the Breeze card. We cannot process a refund if the wrong month is loaded at the Kiosk.

## For Ten-Month Faculty:

If you are in a paid status during the summer, your deduction will continue through the summer months. If you are not in a paid status, and need to continue using MARTA during the summer, you will need to purchase the next monthly benefit at the MARTA kiosk on or after the 23<sup>rd</sup> of the current month. Once you return to paid status, payroll deductions will resume and your Breeze card will be loaded for the following month.

I authorize Georgia State University to withhold the monthly amount indicated from my pay on a pre-tax basis. I understand there will be a division of the monthly MARTA charge across the number of paychecks I receive each month. MARTA Breeze card payroll deductions are a prepaid benefit and I understand there are no refunds associated with this program.
